League Principles

All Binghampton Community Life Center (BCLC)) recreational activities have been established to promote teamwork, good sportsmanship, and cultural/social interaction while having fun in a safe, competitive environment. Players will learn to work together for a common goal, develop friendships and respect for each other. The fans play a critical role in establishing the tone of a game and establishing the example of proper behavior for their children. Criticism of team players on either team or of referees is unacceptable. We promote positive reinforcement of all players, not negative criticism of others. The coaches, players and referees deserve respect, encouragement, support and appreciation from fans. BCLC require the players to display good sportsmanship. No foul language or unsportsmanlike behavior will be tolerated. We require both teams to congratulate each other after the game in a positive manner. We require everyone to remember that basketball, volleyball, T-ball, cheerleading and other sponsored events are simply activities to be enjoyed regardless of the outcome. Always treat others in the same manner you wish to be treated (i.e.- with courtesy, respect and love) and the experience for the players, coaches and fans will be uplifting. Affiliation with a religious organization is not required.
